- 2. The figures for the quarter ended 31 March, 2019 and 31 March, 2018 are the balancing figures between the audited figures in respect of the full financial year and the unaudited published figures upto nine months of the relevant financial year.
- 3. The financial results have been prepared in accordance with the principles and procedures of Indian Accounting Standards ("Ind AS") as notified under the Companies (India Accounting Standards) Rules, 2015 as specified in section 133 of Companies Act, 2013.
- 4. Effective from 01 April, 2018, the Company adopted Ind AS 115 "Revenue from Contracts with Customer". With the adoption of Ind AS 115, no significant adjustments were required to be made to the retained earnings as at 01 April, 2018. The effect on adoption of Ind AS 115 was insignificant on the financial results.
- 5. As per Indian Accounting Standards (Ind AS) 108 "Operating Segment", the Company's business falls within a single business segment viz. Chloro alkali sector/production of Caustic Soda.
- 6. Provision for taxation is made at the effective income tax rates.
- 7. Figures for the previous periods have been re-grouped/re-arranged, wherever necessary, to correspond with the current period's grouping.
- 8. After Applicability of Goods and Service Tax (GST) w.e.f. 01 July 2017, sales are required to be disclosed net of GST accordingly, the figures of revenue from operations for the year ended March 31, 2019 are not comparable with the previous period.

To The Board of Directors of Lords Chloro Alkali Limited

We have audited the annual financial results of Lords Chloro Alkali Limited ("the Company") for the year ended 31 March, 2019 ("the Statement"), attached herewith, being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
