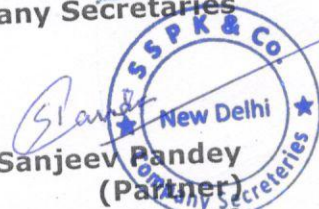

Order: Extension of time for holding of Annual General Meeting (AGM) for the financial year ended on 31.03.2020

1.
